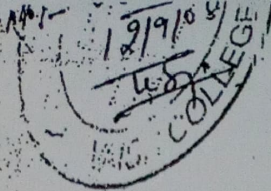

The extension/continuation of above courses is further subject to the conditions that your college shall fulfil all the deficiencies/shortcomings pointed out in the Inspection Report as given below and submit the compliance report of the same to this office upto 30<sup>th</sup> June 2021, so that, the further necessary action may be taken accordingly:

1. Diplomas/Certificates based on Skill Development (i.e. Based on Aatm-Nirbhar Bharat initiative) should be initiated in the college for Graduate and Post- Graduate classes.
2. Since UGC allows diploma/certificate through Distance/ODL/correspondence along with a regular degree from, hence new job oriented vocational courses should be started.
3. Courses from SWAYAM/MOOCs and other online platforms should be made mandatory for every student.
4. Recruitment of regular Principal should be done earliest and got duly approved.
5. Appointment of Director should be got duly approved from CBLU, Bhiwani.
6. Vacant posts of teachers should be filed and got duly approved.

7. Old Library books must be replace/transferred/donated as per rules and new books should be purchased. Computers with e-content should be part and parcel of library. Though library is good, but books of PG Classes except Hindi are very few, hence more books should be part of library. Journals for all PG Classes should be subscribed. Library Management System should be implemented regularly. Books for PGDCA/MCA are very few, therefore necessary purchase should be done.
8. Since the college was established in 1944, renovation of the Science Labs and building is required. Alongwith the computer lab adjacent to main library should be repaired.
9. One more Common Computer Lab with internet facility should be established. Computers and Printers should be procured as per requirement. Since the computer facility available under SFS is being utilized by two courses, i.e. BCA and BBA, hence more computers should be purchased for computer lab.
10. Allowed students' intake is very high, but number of student is very few, hence special efforts should be done to get the students admitted.
11. BBA & BCA courses are running in same building and with almost same infrastructure. The same computer lab and library are being utilized in both the courses. Therefore, more books and computers should be purchased.
12. Since the college was established in 1944, renovation of the Science Labs and building is required. Alongwith the computer lab adjacent to main library should be repaired.
